Although only one record item of 189. Reserve-Division was available and is reproduced on roll 1557 of Microfilm Publication T513, the Order of Battle of the German Army (Washington, D.C., March 1945), the general staff officers personnel files, manuscripts in the Foreign Military Studies series, situation maps of Lage West, and records of OKH/GenStdH/Org.Abt., H 1/38 (T78, roll 398), were used for the unit history.

Record items 46720/1-2, TB mit Anlagen, 1943/04/01-1943/12/31, as listed in the Potsdam catalog were never in the custody of the National Archives. Records of the medical officer of the 189. ResD, EAP 49-n-10/5, for the period 1943/04/22-1944/02/22, were filmed on roll 257 of Microfilm Publication T84, and are listed in Guide No. 36, page 54.
